4. **TERMINATION:** The School requires a full term's notice of termination which must be received no later than the day prior to the commencement of that term.
5. Notice must be given in writing. The parent shall remain liable for all fees and other charges which may become due and payable during the notice period.
6. Should notice not be given, a full term's fees shall be paid in lieu of notice.
7. Interest will be charged on all overdue accounts at the prescribed interest rates.

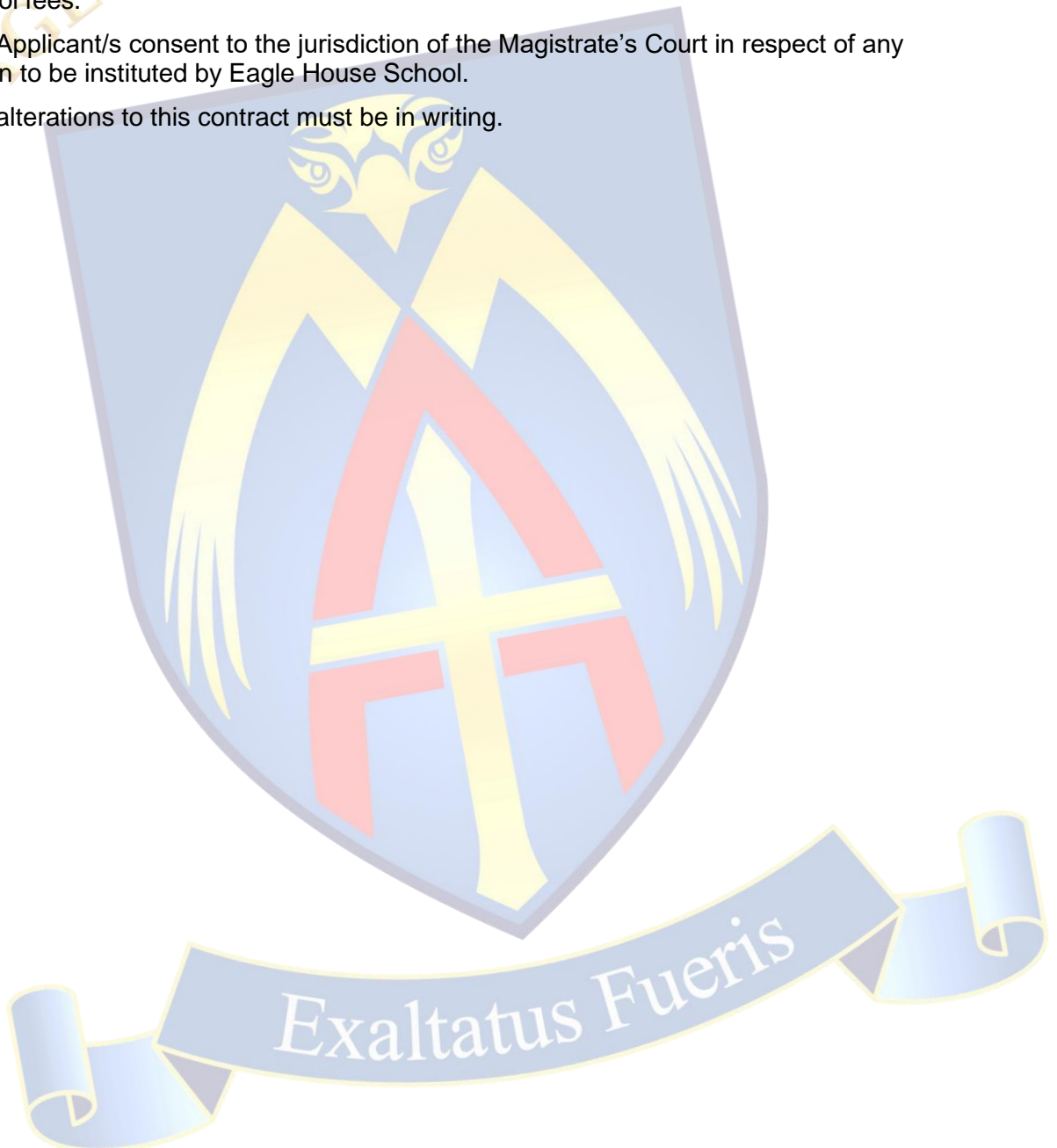
